In the Winter of 2018 we joined forces with the National Diaper Bank Network. With their partnership we were able to increase our funding and distribution goals. Helping families meet their basic needs, distributing 50,000 diapers.





In 2018, we also started the Shelby County Alliance for Period Supplies. A partnership with the Alliance for Period Supplies, a program of the National Diaper Bank Network. This started our mission to restore dignity and health to menstruators in our community, donating 100 period supply kits to students in our Shelby County Schools. We are excited about this new venture and can't wait to see what 2019 has in store.

BY THE GOVERNOR

WHEREAS, access to a reliable supply of clean diapers is a necessity for the health and v infants and toddlers, their families, and child and health providers; and

WHEREAS, the average infant or toddler requires an average of 50 diaper changes per w three years; and

WHEREAS, providing a sufficient supply of diapers can reduce economic pressure of families: and

WHEREAS, a supply of diapers is generally an eligibility requirement for infants and to participate in childcare programs and quality early education programs; and

WHEREAS, when infants and toddlers cannot participate in childcare programs, it mak difficult for their parents and guardians to participate in the workforce, thereby causing of harm to many families; and

WHEREAS, Tennessee is proud to be served by agencies and organizations that reco importance of diapers in helping to provide economic stability for families; and

WHEREAS, Tennesseans are encouraged to donate generously to diaper banks, diaper di to those organizations that distribute diapers to families in need;

NOW, THEREFORE, I, Bill Haslam, Governor of the State of Tennessee, do hereby the week of September 24 - September 30, 2018, as

Recognizing National Diaper Need Awareness Week



Proclamation

- WHEREAS, Diaper Need, the condition of not having a sufficient supply of clean diapers to ensure that infants and toddlers are clean, healthy and dry, can adversely affect the health and welfare of infants, toddlers, and their families; and
- WHEREAS, national surveys report that one in three mothers experience Diaper Need at some time while their children are less than three years of age, and forty-eight percent of families delay changing a diaper to extend their supply; and
- WHEREAS, the typical infant or toddler requires an average of at least 50 diaper changes per week for over three years; and
- WHEREAS, there are no government assistance programs for the purchase or provision of diapers, and a monthly supply of diapers can cost as much as six percent of a full-time minimum wage worker's salary; in many instances, obtaining a sufficient supply of diapers can cause economic hardship to families; and
- WHEREAS, an adequate supply of diapers is generally an eligibility requirement for infant and toddlers to participate in childcare programs and quality early education programs; and
- WHEREAS, Memphians recognize that addressing Diaper Need can lead to economic opportunity for the area's low-income families and can lead to improved health for families and their communities; and
- WHEREAS, Memphis is proud to be home to various community organizations that recognize the importance of diapers in helping provide economic stability for families and distribute diapers to low-income families through various channels.

NOW, THEREFORE, I, JIM STRICKLAND, MAYOR OF THE CITY OF MEMPHIS, TENNESSEE, do hereby proclaim September 24 - 29, 2018 as

DIAPER NEED AWARENESS WEEK

in our city.
